## Minutes of Meeting of State Level Quality Assurance (SQAC)

Dated: 16<sup>th</sup> December 2020 Venue: NHM Conference Hall, Shillong

Under the Chairmanship of Shri Sampath Kumar, IAS, Commissioner & Secretary, Health & Family Welfare Department, Government of Meghalaya a State Level Quality Improvement Initiative - LaQshya Review Meeting was held along with Shri. Ram Kumar S, IAS, Jt. Secretary, Health & Family Welfare Department, Government of Meghalaya cum Mission Director, Director (MCH & FW), Joint Mission Director (NHM) cum State Nodal Officer - MH, State Nodal Officer - CH and District Maternal and Health officers from 11 districts and other members as per notification.

Following points were discussed amongst committee members by Joint Mission Director (NHM) cum State Nodal Officer - MH.

- 1. An orientation on Family Planning Indemnity Scheme was given. Under the Family Planning Indemnity Scheme, it has been decided that districts would process and make payment of claims to beneficiaries of sterilization in the event of death/failure/complication and indemnity cover to health facilities and the payment has been doubled since 14.09.2016.
- 2. There were 3 (Three) failure cases in FY 2019-2020, but the payments could not be made due to incomplete documents. Hence the districts were advised to fill up all the related documents to process the claims in such cases. Also, District Indemnity Scheme Committee (DISC) should verify all the documents before sending to the state.
- 3. No claims were reported in FY 2020-2021.
- 4. The claims will fall within the "Family Planning Indemnity Scheme" only if the beneficiary files the claim with the DISC within 90 days from the occurrence of the event of death/ failure/complication.

The meeting ended with a vote of thanks from the chair.
