1. Competitive offers in sealed covers super scribed with the statement “Tender for Sale of Old and Used Scrap Vehicles” are invited from interested parties for disposal on “AS IS WHERE IS” basis.
2. The Tender Notice containing detailed terms and conditions are also available on <http://nhmmeghalaya.nic.in/> website Interested parties can download the Tender Document and submit their offer.
3. The scrap material can be inspected at ERS Dial 108 office, Lawmali, between 11:00 AM to 4:00PM up to 18.10.2024 on any working day.
4. Bidders are accordingly requested to quote your highest rates for lifting the Vehicle Scrap. The proposal should be submitted in two parts viz. “Technical Bid” and “Commercial Bid” in the Performa enclosed at Annexure- C and Annexure- D, respectively. Filled in Annexure-C & Annexure-D should be sealed in separate envelopes and appropriately super scribed with the statement “Technical Bid” or “Commercial Bid” as the case may be and then sealed in a bigger envelope super scribed with “Bids for Disposal of Old and used scrap vehicles”. The sealed cover should be addressed to Mission Director, National Health Mission, Shillong, and reach on or before 04:30 PM of 18th October, 2024. The ‘Declaration Form’ at Annexure-A forming part of the inquiry should be signed and submitted along with the offer in token of acceptance of terms and conditions of the Tender. The Tender would be opened on 23rd October at 01:00PM, NHM Conference Hall laitumkharh. The bidders may depute their personnel for the bid opening event, if they so desire.
5. The offer shall accompany an Earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees ten thousand only). The EMD should be submitted in the form of Demand Draft drawn in favor of the **M/s State Contribution Account (NHM) bearing Account No : 01529460000500 Yes Bank Ltd.** Tenders without EMD will be summarily rejected.
6. NHM reserves the right to accept/reject any/all offer(s) without assigning any reason whatsoever.

SCOPE OF TENDER:

1. Successful H1 bidder will be intimated by NHM for removal of scrap vehicles on urgent basis and the successful bidder has to remove/lift the stock within seven days upon remittance of the sale amount on accepted rate before taking delivery.
2. If the stock has not been removed/lifted within seven days on intimation, NHM has the right either to sale of in the H2 rate or to negotiate with the H2 bidder to meet the H1 rate and to lift/remove the stock.

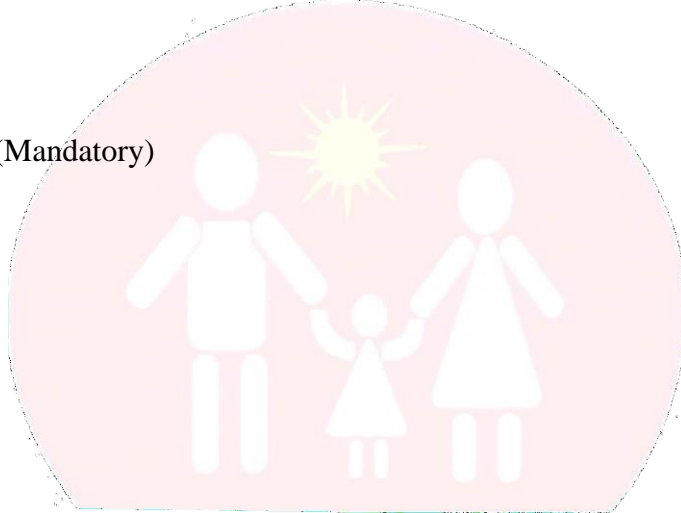

TERMS AND CONDITIONS

1. The sale shall be on "AS IS WHERE IS" basis
2. The scrap materials shall be picked from the following location/area:- Emergency Response Service Dial 108, 1st Floor Neurological Building, MIMHANS, Lawmali, Shillong - 793001, Meghalaya, North East India & from Nongum PHC, Rambrai PHC, Kynshi PHC West Khasi Hills District
3. Tenders are to be submitted in sealed covers and should be submitted within the last date and time specified in the tender document.
4. The quoted price, shall be submitted in the Price Format at Annexure-D, forming part of the Tender Inquiry. Prices are to be quoted unit wise.
5. Tenders shall be accompanied by the EMD of Rs.10000/- (Rupees Ten thousand only) in the form of Demand Draft drawn in favor of Mission Director, National Health Mission. Under no circumstance, amounts that are due or likely to be due from NHM will be adjusted against the EMD. No mode of payment other than the above will be accepted. EMD amount will not carry any interest. Tenders without EMD will be summarily rejected.
6. The tender shall be open for acceptance for a period of thirty (30) days from the date of opening the bids. In case of withdrawal of tender within this period, the EMD remitted by the bidder will be forfeited.
7. The tender shall be written legibly and free from erasing and over-writing. Corrections, if any, should be duly countersigned by the authorized signatory. Rates should be written both in words and in figures. In case of difference in the rates indicated in figures and words, the rates indicated in words would be treated valid.
8. The bidders are required to indicate their PAN Number in their offer since it has been made mandatory by I.T. Department.
9. All labour, tools and equipment for removing/loading the scrap from Mission Director, National Health Mission Office shall be organized by the buyer on their own cost. The personnel employed for shifting the items shall strictly obey the safety rules in force and NHM will not be responsible for breach of any rules by the personnel of the buyers in any way whatsoever. The job shall be done without damaging the premises/ roads/ drains/ etc.in the compound. The buyer shall make good the damages, loss, etc., in the event of any such occurrence.
10. Tenders submitted without fulfilling the above term & conditions and in contravention to the tender notice are liable to be rejected summarily.
11. The Tender Notice and connected Annexures shall form part of the contract.
12. The scrap item to be sold can be inspected on any working day as per schedule given in tender notice with prior appointment.
13. The successful H1 bidder would be awarded the contract for removal/ lifting the Scrap Vehicles and shall remit the sale amount on accepted rates of the scrap items before taking delivery of the same from NHM.
14. The awardees should remove all scrap items at their own cost from ERS 108 Lawmali Shillong-793001 & Nongum PHC, Rambrai PHC, Kynshi PHC West Khasi Hills District with a proper Gate Pass during working hours within 7 days from the date of Order/Notice.
15. EMD/Security deposit will be forfeited in case scrap is not lifted by the selected bidder within the prescribed timeline.
16. All statutory payments, like minimum wages prescribed, compensation in case of accident or loss, etc., to the workers employed by the bidder for the removal of the items shall be borne by the bidder

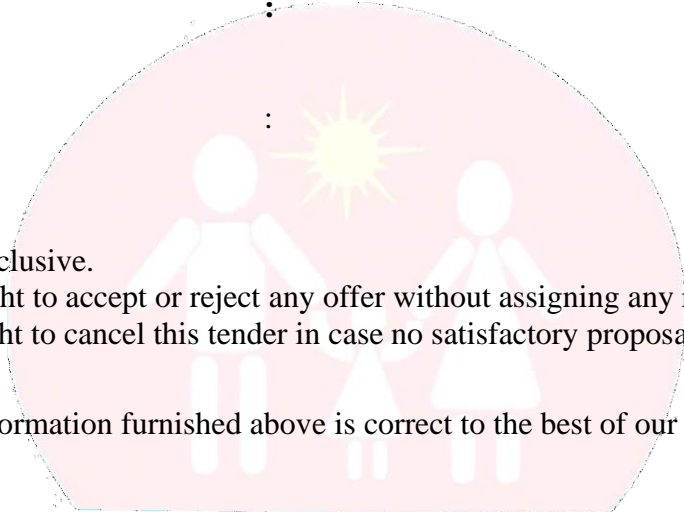
