1. Post Technical bid opening it was observed that all bidders had furnished all documents, except the following:

- a. R.K.S Enterprise: Blood Sugar Test strip-Accusure and Blood Sugar Test strip-Gluco one, the Authorization letters were not from the relevant OEM.
- b. Arengh Medical Supplier: Blood Sugar Test strip-Code Free, Blood Sugar Test strip-Gluco one the Authorization letters were not from the relevant OEM and for Fixomul stretch 10 * 100 cm The authorisation provided was not from the Manufacturer.
- C. R.G.S Enterprise: Blood Sugar Test strip-Code Free, No Authorization from the Manufacturer.
- d. In view of the above mentioned deviations, the items will not be considered in the financial bids opening for the bidders.
- Since all bidders submitted the quality-related certification, all items are considered to be compliant. However, if it is learned after delivery that the items do not conform to the quality standard, it is the L1 or the supplier's responsibility to provide replacements of the same and bidders' objection are deemed waived.
- 3. All bidders are qualified for the financial bid opening.
