### CIRCULAR

Sub:- Cancelling of Tender

Ref :- RFP No.: DHS/MCH&FW/NHM/NDHM/39/2021 /1796

The Mission Director, National Digital Health Mission had floated a Request for Proposal bearing the RFP No.: DHS/MCH&FW/NHM/NDHM/39/2021/1796 regarding “Selection of an Agency for running of Program Management Unit (PMU) to assist in National Digital Health Mission (NDHM) in Meghalaya” which was published on our Website (<http://nhmmeghalaya.nic.in>) on 2nd September 2021. The State Digital Health Mission of Meghalaya intended to appoint a consulting agency which was to act as a Project Management Unit (PMU) for delivering consulting services for project development and project management activities, in order to assist the State in an effective project implementation and governance of NDHM.

As on the last date of submission, i.e. 20th September 2021, the State had received a total of only two submissions for the floated RFP from the following firms:-

Since the assignment was time bound, the Department had gone ahead with the evaluation of the proposals submitted by the two firms only.

However, the State and the concerned authorities have reassessed the scope of work covered in the above mentioned RFP and is now considering to propose an expansion to the same by including implementation of the assignment along with setting up of the PMU among other key aspects of the mission (as a Project Implementation Unit and not only a Management Unit) across the entire state or parts of the State which would avoid any overlapping or creating duplication for the existing scope of work.
