- 1. Based on the evaluation criteria, M/s Marak Supply & Agencies scored 58 out of 100, which falls short of the minimum technical qualification benchmark of 60 out of 100. The committee, therefore, decided not to invite M/s Marak Supply & Agencies for the Financial Bid Opening.
- 2. Over and above the given criteria for the two potential firms, the committee meticulously reviewed on the entire proposal which include Drawings and methodology, Adherence to equipment requirements, Financial capacity and other relevant submissions. The accompanying site assessment reports were also thoroughly examined.
- 3. Comparative Scoring Statement (Annexure-1): The detailed scoring for the two technically qualified firms is as follows:
 - a) M/s Sandor Medicaids Pvt Ltd: Technical Score: 71 out of 100, Weightage at 80%: 56.8

b) Arengh Medical Supplier: Technical Score: 70 out of 100, Weightage at 80%: 56

- 4. The evaluation committee, having found both firms to be technically qualified, recommends proceeding to open the Financial Bids of both parties. However, the committee strongly advises conducting a meticulous evaluation of the Financial Bids to ensure alignment between the equipment lists proposed by both firms and the specific requirements of NHM. This thorough assessment is deemed essential to prevent any potential confusion during the issuance of Work Orders and the signing of Agreements at a later stage.
- 5. The committee has decided to invite the following firms for the Financial Bid Opening:
 - a) M/s Sandor Medicaids Pvt Ltd
 - b) Arengh Medical Supplier
