- There was a brief presentation by Mr. Kmenbhalang Khongwir, RTC NHM Meghalaya and Mr. Happylyne Sanglyne Basan, SCM ERS, Dial 108, about the process of obtaining Tender Document and Earnest Money Deposit (EMD), the steps that to be followed in the bidding process particularly on having two Envelope system for Pre- Qualification & Technical Bid and Commercial Bid (Price Bid). The PPT also covered the details of documentation required to be submitted by the respective bidders.

### Points of Discussion:

1. Some bidders enquired whether the Earnest Money Deposit should be submitted in the form of Banker Cheque or Call Deposit other than the Demand Draft.

**Response:** As unanimously agreed, it was decided to adhere with only Demand Draft.

2. Interested bidders wanted to know whether the commercial bid will be evaluated for individual vehicle or overall lumpsum amount for all the vehicles. they can submit the lumpsum amount or not for the commercial bid or what if one bidder is the highest quote for one vehicle and can be the H1.

**Response:** It was clarified that bidder will have to mention the valuation for each and every vehicle, however the evaluation will be for the cumulative amount. The highest bidder H1 will be for the total value of 31 Vehicles will be considered.

3. Bidders wanted to clarity on the Annual Turnover: 2019-20, 2020-21 & 2021-23 mentioning that they might not be able to get for 2020 being the lockdown period.

**Response:** As suggested by Financial Adviser, Bidders can submit the Average Turnover for 2019-20, 2020-21 & 2021-22 and they can submit with a Provisional Turnover Amount through a Chartered Accountant instead of Income Tax Returns.
