NOTICE

Following bid opening which was held on 19th/Dec/2022 and 20th/Dec/2022 pertaining to Tender for “construction of Integrated Health Complex + RCC G+1 Staff Residential Apartment at BALJEK and Integrated Public Health Laboratory (IPHL) at Pasteur Hills on turnkey basis” vide Tender Notice No: DHS/MCH&FW/NHM/Civil & Eqpts/120/2022/3321, dated 29th/Nov/2022, placed below the findings and decision thereafter:

sl. no.	Bidder's Name	Remarks
1	Star Infratech Andreas T. Sangma	Bidders are qualified
2	Bithmingson Sangma	As a result of the bidder's failure to completely comply with the Tender document's terms and conditions, hence disqualified.

1. The qualified bidders have submitted all documents and regarding supply, if it is learned after delivery that the items do not conform to the quality standard, it is the successful bidder or the supplier's responsibility to provide replacements of the same and bidders' objection are deemed waived.
2. Following the technical bid opening, it was observed that Star Infratech and Andreas T. Sangma provided all required documentation in accordance with the terms and conditions of the NIT document, hence qualified.
3. Bithmingson Sangma, the bidder did not provide all documentation and has no experience in similar work as per the criteria, hence disqualified.
4. The qualified bidders were assigned a technical score based on the proof documentations furnished by the bidders and the presentation marks awarded by the Committee members.
5. Star Infratech and Andreas T. Sangma scored more than the minimum qualifying score, hence the bidders are eligible to participate in the financial bid opening and QCBS.
6. In accordance with the criteria outlined in the NIT document, the final evaluation of the selected bidder is undertaken using QCBS with a 70:30 weighted score.
7. Star Infratech's combined score is the highest and the contract will be awarded to the bidder with the highest score.
8. Any clarification to the above tender may be seek from the office of the undersigned within 7days of the notice date.
